



**Third Party Authorization to Enroll**

This Authorization is given on this \_\_\_\_\_ day of \_\_\_\_\_, 2018 by \_\_\_\_\_ (“Customer”) to Integrity Energy, LLC. (“Representative”/“IE”) the coordinator of bulk Electricity and Natural Gas procurement on behalf of multiple commercial, industrial, and governmental entities (“Affiliates”).

This authorization declares Customer’s appointment of Integrity Energy, LLC. (“Representative”/“IE”) as its authorized agent to act on behalf of Customer and to secure electricity and natural gas rates for Customer’s accounts. Customer hereby declares and gives Representative/IE approval to act on Customer’s behalf with regard to inclusion of Company in the Affiliate for purposes of negotiating, transacting and executing agreements with third-party suppliers involving the purchase of electricity and natural gas products.

Customer acknowledges and agrees that Representative/IE may provide to third-party suppliers Customer information needed to secure electricity and natural gas pricing (to include but not limited to Kwh and Ccf usage) and gives permission to Representative/IE to sign supply agreements with certified retail natural gas and electric suppliers on Customer’s behalf. Customer authorizes suppliers to obtain Customer’s usage information from its utilities. Representative/IE will make available to Customer a sample of agreements from prospective suppliers for Customer’s review. Customer understands that a Transaction Confirmation (“TC”) will be sent to Customer with details of all agreements signed on Customer’s behalf. Once enrolled by the retail supplier, customers other than those defined as Mercantile shall have the right to rescind their enrollment with the retail supplier within seven calendar days following the postmark date on the utility’s confirmation notice.

Customer understands it (1) will be bound by any electricity and natural gas agreements signed on their behalf as if it were signed by the Customer; (2) will remain responsible for all obligations incurred on its behalf by Representative/IE; (3) shall indemnify and hold harmless Representative/IE and any contracted third-party supplier against claims, losses, liability or expenses as a result of actions performed by Representative/IE under this Authorization; (4) shall contact any current supplier(s) and provide notice of termination if necessary, based upon acceptance of a TC.

Representative/IE will notify Customer in writing at least 30 days prior to the expiration of all agreements and transactions made on behalf of Customer through the Affiliates.
