

### **CHHSM—Who We Are!**

75 nonprofit corporations recognized by the Conferences and General Synod of the United Church of Christ, encompassing 417 facilities and programs. Collectively we provide:

- Affordable Housing: 302
- Services to the Aging: 82
- Services to Children, Youth and Families: 20
- Transitional and Shelter Care: 7
- Primary and Acute Health Services: 3
- Services to Persons with Disabilities: 2
- Charitable Grant Making Foundations: 1

### **Service Statistics**

- Operated 21,506 affordable housing units
- Operated facilities with 6,065 beds providing acute & skilled nursing care
- For older adults, operated 10,237 independent and 3,301 assisted living units
- Provided community-based ambulatory health care to over **2.2 million people**
- Cared for 26,509 children and youth in residential & non-residential programs
- Provided residential & non-residential services to 350+ with developmental disabilities
- Provided 198,295 hours of volunteer service
- Provided over **\$1 billion** in uncompensated & charitable care
- Received \$62.5 million in charitable contributions





### **2023 Operating Revenues**




### **2023 Operating Expenses**





# **Nominating Committee**

#### **ARTICLE SIX: COMMITTEES: Section 6.3 Nominating Committee**

In order to recruit and identify qualified candidates to serve as Elected Directors, Appointed Directors, **officers** and members of a Nominating Committee, the Members shall, at each annual meeting, by majority vote of the Representatives of Members present at a duly called and convened meeting of the Members, elect a Nominating Committee consisting of at least five (5) members, at least one (1) of whom shall be an Elected Member of the Board of Directors and all of whom shall be either employees or directors of a Member (the "Nominating Committee").

The Nominating Committee shall propose slates of candidates sufficient to fill current vacancies and expiring terms of Elected Directors, Appointed Directors, <del>officers</del> and members of the Nominating Committee.

# **Governance Standing Committee**

#### **ARTICLE SIX: COMMITTEES: New Section 6.4 Governance Committee**

The responsibilities of the Governance Committee shall include the following:

- a. Board Officers and Executive Committee: The Committee shall be responsible for **nominating qualified Voting Directors to serve as officers of the Board and on the Executive Committee**. This includes assessing the skills, diversity, and expertise needed to enhance the overall effectiveness of the officers of the Board and Executive Committee.
- b. Board Orientation and Education: The Committee shall oversee the development and implementation of orientation programs for new Directors and facilitate ongoing education opportunities to enhance the understanding of CHHSM's mission, vision, and strategic objectives.
- c. Board Performance Evaluation: The Committee shall establish the processes for evaluating the performance of the Board, its committees, and individual Directors. This includes periodic assessments to ensure alignment with CHHSM's mission and strategic goals.
- d. Governance Policies and Procedures: The Committee shall review and recommend updates to the CHHSM Bylaws and governance policies, ensuring that they remain current, relevant, and in compliance with legal and regulatory requirements.
- e. Conflict of Interest Oversight: The Committee shall oversee the process of identifying, disclosing, and managing conflicts of interest among Directors, Officers, and key executives to maintain the integrity and public trust of CHHSM.

## **Executive Committee Composition**

#### **ARTICLE SIX: COMMITTEES: Section 6.1 Executive Committee**

In order to allow decisions with respect to policy and management of the Council to be made when the Board of Directors is not meeting, there shall be constituted an Executive Committee (the "Executive Committee") consisting of the Chair, Vice Chair, Treasurer and two additional members of the Board of Directors elected by the Board of Directors from among the **Voting Directors** (collectively, the "Elected Members"); provided that at all times **three of the Elected Members must be Elected Directors**.
